# Improve ease of doing business

## Experts urge govt at DCCI virtual discussion

STAR BUSINESS REPORT

Bangladesh should focus on creating an effective business-friendly environment and improving the ease of doing business in the country, top businesses said in a virtual discussion yesterday.

"The ease of doing business is essential to reduce the cost of business as global trade is getting more competitive," said Rizwan Rahman, president of the Dhaka Chamber of Commerce and Industry (DCCI).

After the United Nations status graduation in 2026, Bangladesh will lose most of the preferential trade benefits, which may hurt the country's competitive export market, he said at the event.

Given these circumstances, it is high time to address the bottlenecks, reduce time, process and cost in all criteria of the doing

business and streamline the entire process towards lifting the indicators of the index, he added. The Dhaka chamber organised the event on the "Current reforms in the ease of doing business in Bangladesh and preparedness for the future".

The ease of doing business is a big thing, said Sirazul Islam, executive chairman of Bangladesh Investment Development Authority (Bida), as the chief guest.

"We would not like to mainly focus on scoring high. Rather, we are trying to create a business-friendly environment. Some of the reforms have already been brought about by the government, through the coordination of the Bida," he said.

He, therefore, requested the private sector to take note of the reforms and reports based on facts.

# Coordination between govt agencies, pvt sector needed to attract FDI

Apart from the government initiatives, positive response from the private sector about the business environment is essential for performing well in the Ease of Doing Business ranking, speakers said at a programme on Tuesday.

They also said better coordination between the government agencies and the private sector is required to attract more foreign direct investments (FDIs) in the country.

The observations came at a virtual discussion meeting on "Current Reforms in Ease of Doing Business in Bangladesh and Preparedness for the Future" organised by Dhaka Chamber of Commerce & Industry (DCCI).

### Speakers tell DCCI discussion

(BIDA) Executive Chairman Md Sirazul Islam addressed the programme as the chief guest while BIDA executive member (investment environment services) Md. Billal Hossain as the special guest.

Discussing different aspects of EoDB ranking prepared by the World Bank (WB), Mr Islam said there are two aspects of the EoDB. Firstly, the WB set some targets for reform of service delivery and secondly, a survey is conducted to take response from the businesses about reforms.

Mentioning that BIDA always welcomes criticisms and suggestions from its stakeholders, he said in some cases, it is observed that reforms of different services don't reflect in the ranking properly.

"If reforms are not helpful for the businesses, I request them to come forward with further evaluation of our work so that the government service deliveries get smoother."

Mr Islam acknowledged that it is easier to give an instruction from policymaking level but it is not always easy to do the task at implementation stage.

To provide one-stop services (OSS) to businesses, BIDA has so far signed MoUs with 25 government agencies of which 48 services of the 16 agencies are now available under OSS, he



বিশেষ অতিথির বক্তব্যে বিডার নির্বাহী সদস্য মো, বিল্লাল হোসেন বলেন, ব্যবসা পরিচালন সূচকে অবস্থান ভালো করতে পারলে বহির্বিশ্বে বাংলাদেশের ভাবমূর্তি বহুলাংশে বাড়বে। এর ফলে দেশি-বিদেশি বিনিয়োগও বাড়বে। তিনি জানান, বিডার ওয়ান ঈপ সার্ভিসের মাধ্যমে অনলাইনে বর্তমানে ৪৮টি সেবা দেওয়া হচ্ছে।

বিডার পরিচালক জীবন কৃষ্ণ সাহা ওয়েবিনারে মূল প্রবন্ধ উপস্থাপন করেন। তিনি বলেন, ব্যবসা শুরু, ভূমি নিবন্ধন, বিদ্যুৎ সংযোগ প্রাপ্তি, ঋণ প্রাপ্তি, বিনিয়োগকারীদের সংরক্ষণ, অন্যান্য দেশের সঙ্গে বাণিজ্য এবং কর প্রদান প্রক্রিয়া প্রভৃতি বিষয়ে বেশ কিছু সংস্কার কার্যক্রম বাস্তবায়ন করা হয়েছে। তিনি বিশ্বব্যাংক পরিচালিত জরিপে উত্তর দেওয়ার সময় সরকারের সংস্কার কার্যক্রমগুলো বিবেচনায় নেওয়ার জন্য ব্যবসায়ী সমাজের প্রতি আহ্বান জানান।

# ব্যবসা পরিচালনা সূচক দেশের অবস্থান ডাবল ডিজিটে আনতে হবে

ব্যবসা পরিচালনা সূচকে বাংলাদেশের অবস্থান ডাবল ডিজিটে নামিয়ে আনতে হবে। এ লক্ষ্যে সরকার গৃহীত সংস্কার কার্যক্রম সম্পর্কে বেসরকারি খাতকে জানানো জরনর। বাংলাদেশ বিনিয়োগ উন্নয়ন কর্তৃপক্ষের (বিডা) নির্বাহী চেয়ারম্যান মো. সিরাজুল ইসলাম গতকাল 'বাংলাদেশে ব্যবসা পরিচালনায় ব্যয়হাস কার্যক্রমে চলমান সংস্কার এবং ভবিষ্যতের প্রস্তুতি' শীর্ষক ভার্চুয়াল সভায় এসব কথা বলেন।

ঢাকা চেম্বার অব কমার্স অ্যান্ড ইন্ডাস্ট্রি (ডিসিসিআই) এবং বিডা আয়োজিত সভায় ব্যাণিজ্যবিষয়ক সংস্কার কার্যক্রম বাস্তবে কতটা বিদ্যমান আছে, সেটা পর্যবেক্ষণ করতে বেসরকারি খাতকে আহ্বান জানান তিনি। বিডা চেয়ারম্যান বলেন, সংস্কারের ক্ষেত্রে নীতিমালা খব সহজে সংশোধন হলেও মাঠপর্যায়ে সেটা বাস্তবায়নে মাঝেমধ্যে শিথিলতা দেখা যায়। তা সমাধানে সংশ্রিষ্ট সংস্থাগুলোকে অগ্রণী ভূমিকা পালন করতে হবে। তিনি জানান. এক কোম্পানি থেকে অন্য কোম্পানিতে ভূমি হস্তান্তরের নথি নিবন্ধনে সারা দেশের ভমি অফিসগুলোতে আলাদা বালাম বই ব্যবহার হচ্ছে। এতে অল্প সময়েই ভূমি নিবন্ধন প্রক্রিয়া সম্পন্ন করা যাচ্ছে। প্রক্রিয়াটি বিডার ওএসএসের মাধ্যমে করা যায় কি না. তা নিয়ে কাজ চলছে। তিনি আরও জানান, ব্যবসায়িক বিরোধ সহজেই নিম্পত্তিতে এডিআরের বিকল্প নেই। আরবিটেশনের নিষ্পত্তিতে সময় নির্ধারণ করা প্রয়োজন বলে মতপ্রকাশ করেন। সিরাজুল ইসলাম বলেন, ঢাকা ও চট্টগ্রামে আলাদা দৃটি আদালত করা হবে। এতে শুধু ব্যবসায়িক বিরোধবিষয়ক মামলা পরিচালনা করা হবে। ওএসএস-সেবা দিতে ইতিমধ্যে ২৫টি সংস্থার

সঙ্গে সমঝোতা স্মারক সই করেছে বিডা। দেশের সরকারি ও বেসরকারি খাত একযোগে কাজ করতে পারলেই ব্যবসা পরিচালনার সূচকে বাংলাদেশের অবস্থানের দৃশ্যমান অগ্রগতি পরিলক্ষিত হবে বলে জানান তিনি।

দেশের বেসরকারি খাত সরকারের সঙ্গে কাজ করতে আগ্রহী।
