### Tender Notice for the appointment of Engineering / Architectural Design Consulting Firm for ground-floor car parking development.

The DCCI Authority has decided to remodel its ground floor with a Car-Parking zone & other works (±10,000 sft.) at 65-66 Motijheel Commercial Area, Dhaka-1000.

Accordingly, the DCCI is seeking experienced engineering/architecture companies who are experienced in remodeling, are hereby invited to place a proposal for the architectural, structural and technical design & drawing consultancy in the tender box by 30th May 2022 at 4:00 pm which has been kept at DCCI Secretariat, 4th floor (Estate department).

### Scope of Works:

Eligible bidders may propose consultancy service proposals including architectural, structural and technical design-drawing mentioning the following scopes and any other scope related to this:

- 1. Floor Rising-Leveling, for rainwater protection,
- 2. Maximum car parking facilities including a stacking system (if possible),
- 3. Repositioning of±1250 KVA dry type/oil type transformer including HT&LT switchgear, PFI, earthling, cabling, etc,
- 4. Re-installation of existing 3 Diesel Generator,
- 5. Re-arrange the sewage-sanitary plumbing system,
- 6. Ground floor sewerage drainage pit-line,
- 7. Upgrading existing service system,
- 8. Upgrading utility and security system,
- 9. Upgrading Fire Fighting System as per BNBC,
- 10. Maintaining floor rising and to be scheduled effected components as well,
- 11. Face lifting both North & Southside up-to 1st floor including placing signboard,
- 12. Electrical development /up-gradation including MDB, SDB, etc.
